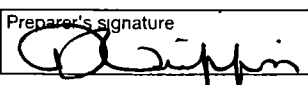

In 2017, the Abundance Foundation provided program services, staff support and grant administration for the implementation of Agency by Design (AbD), a research project exploring the promises, practices, and pedagogies of maker-centered learning. The project began in 2011 as a collaboration between the Abundance Foundation and Harvard Graduate School of Education's Project Zero. The Abundance Foundation received grant funding from the Harvard Graduate School See Part III, Ln 4a statement

The Abundance Foundation provides program support and grants to organizations aligned with its mission to improve global health by strengthening local health systems and by training and supporting local health practitioners and leaders. Dr. Stephen Kahn, the Foundation's President, is a board-certified emergency room physician with extensive experience working in the global health arena. He provides clinical expertise and on-the-ground engagement with the Foundation's Health program partners and represents the Foundation in various venues. The Abundance Foundation supported the Global Pediatric Alliance to improve maternal and infant health in Mexico and Central America in 2017 by funding the capacity building of their small grants program. This grant program supports See Part III, Ln 4b statement
