TSOKNYI HUMANITARIAN FOUNDATION RAISES FUNDS AND COORDINATES FUNDRAISING INTERNATIONALLY FOR ONGOING SUPPORT AND EDUCATION FOR APPROXIMATELY 220 TIBETAN BUDDHIST NUNS IN NEPAL. THF HAS BEEN RAISING FUNDS SINCE 2012 FOR A CAPITAL CAMPAIGN TO BUILD TSOKNYI GECHAK LING NUNNERY ON CHOBHAR HILL OUTSIDE OF KATHMANDU, NEPAL. THE BUILDING PROJECT CONSISTS OF 6 BUILDINGS. THE TOP 3 PRIMARY SERVICES ARE TO PROVIDE FUNDING TOWARDS CONSTRUCTION OF A THREE YEAR RETREAT BUILDING, A PRIMARY SCHOOL AND AN INTERNATIONAL MEDITATION CENTER.
