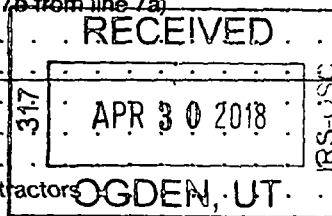

4Sarah's mission is to empower change in the life direction of women and girls who are adult entertainers, prostitutes, escorts, or victims of sex trafficking by offering a holistic approach, as well as an educational, emotional, physical, and spiritual support system

Part III 28-Outreach Program Accomplishments:

4Sarah's outreach team delivered over 3000 gift bags to women that work in strip clubs. Our call center team contacted over 920 women and girls that work on escort websites. We identified potential DMST or adult victims and provided info to local law enforcement to recover victims.

Part III 29-Intervention Program Accomplishments:

4Sarah's intervention program received 329 hotline calls from women seeking information or assistance. Our intervention program assisted 49 women or girls financially that helped with emergency expenses such as rent, utilities, bus tickets, medication expenses, transportation, expenses, food and other urgent requests. Our care team actively mentors 181 women that are transitioning out of the sex industry.
