Explanation of Part XIII, Line 2a: Undistributed Income, if any, at the end of 2017

The 2017 Return entry for Part XIII, line 2a, does not match the related 2016 Return Part XIII line 6f entry for Undistributed Income. The 2017 Return corrects for an error in the 2016 Return.

This Exhibit is intended both to explain the 2017 Return variance, as well as to correct p9/Part XIII of the 2016 Return. (corrected copy provided as Explanation p2/2)

While the 2016 Return entry was in error, all required distributions were met/exceeded, on-time.

Late 2017, in preparing Distributions required during 2017, an inadvertent deletion was identified in a spreadsheet cell related to Line 2a for the prior year 2016 return. This deletion propagated through Part XIII Line 4a and Line 4d, ultimately impacting the Line 6d Undistributed income of 2016 to be distributed during 2017.

Specifically (as also illustrated on Explanation p2/2):

- this deletion caused Line 2a to be shown as 0.00, rather than the correct 8,639.28, as flows from 2015 Return Line 6d, with an identical effect on Line 4a;
- leading to corresponding overstatement of Line 4d (shown as 8,725.00, instead of correct 85.72);
- thus causing understatement of Line 6f (shown as 9,664.86, instead of correct as 18,304.14), as now reflected in this 2017 Return.

We apologize for the error and any additional review this may have caused, and we hope that this explanation and correction within this 2017 990-PF return will suffice for all.
