The organization was active at the legislature on budget policy, school choice, criminal justice reform and ending the practice of taxpayer funded lobbyists. Due to our efforts, the organization was successful in passing legislation prohibiting state agencies from hiring contract lobbyists, expanding the empowerment scholarship account program for K-12 students, limiting the use and practice of civil asset forfeiture and consolidating the election dates on which proposed sales tax increases may be considered. The organization also secured additional resources for the freedom centers established at our state Universities. The organization also defeated several corporate welfare bills that provided special interest tax breaks to businesses and industries.

4b (Code) (Expenses \$ 183,000. including grants of \$) (Revenue \$)

The organization participated in several community events and education efforts. The organization hosted monthly lunches and seminars to provide policy updates on pending legislative action and ballot measures. The organization hosted an event on the future of transportation policy in the State of Arizona and why fixed rail passenger transit is the wrong approach. Additionally, the organization was active in research and educating residents on the beneficial impacts of school choice in Arizona.

4c (Code) (Expenses \$ 56,000. including grants of \$) (Revenue \$)

The organization engaged in a lengthy education campaign with citizens and elected officials on the use of tax subsidies and corporate welfare in Arizona. The education campaign was in response to efforts to create a special stadium district for professional hockey, allowing for the refundability of tax credits for select corporations. As a result of our education efforts, both subsidy efforts were halted and taxpayers were saved millions.

The measure was approved with 51% of the vote, but has been challenged in court due to the illegal nature of the tax. The organization also was a party to a challenge over the constitutionality of Proposition 206, the minimum wage initiative. The organization also produced several articles and reports which have been published on the organization's website.
