Since its founding in 2001, the Children's Cancer Partners of the Carolinas (CCP) has assisted hundreds of families in obtaining lifesaving cancer treatment services for their children, primarily with treatment travel, food and lodging assistance. This often involves financial support for very distant travel to specialized treatments, but also help with the burdens of home caregiving. CCP also provides social support programs for the families through our monthly Family Nights, Back-to-School and Holiday events, the annual Camp Victory, as well as grief counseling and end-of-life expenses. In the year reported here, we have served at least 750 cancer children, along with their siblings and parents/caregivers.
