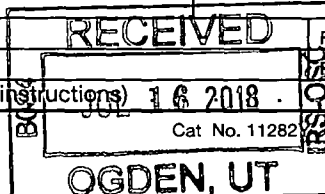

The Downtown Association of Yakima has the goal of making the City of Yakima's urban core the premier place to live, work, and play. Principal activities include a facade restoration program, Saturday family activities, monthly educational breakfast meetings, free summer evening concerts, maintaining hanging flower baskets and street level floral planters, removing garbage and graffiti, and promoting downtown businesses and other activities that boost the safety, appearance, and vitality of downtown Yakima.

Hanging Baskets and Flowers--the Downtown Association maintained approximately 300 baskets of flowers that hang from the city street lamp poles, as well as purchased and maintained the plants that fill 331 street level concrete planters of various sizes and shapes. This is a daily responsibility of the Association. (See note in Schedule O)

4b (Code:) (Expenses \$ 68,819 including grants of \$) (Revenue \$)

Downtown Maintenance- Under a contract funded by downtown businesses in a special improvement district, the Association began, on July 1, 2017, a daily pickup of garbage from city-owned receptacles, repairs and monitors irrigation in all downtown public spaces and streetsides, prunes street trees as needed, performs weed control, and all other maintenance needs on public property in the downtown core.

4c (Code:) (Expenses \$ 154,777 including grants of \$) (Revenue \$ 215,341)

Special Events and programs - The Association has a number of core activities that either seek to improve the appearance of downtown or attract people to visit the downtown core. These include a facade improvement grant that will provide up to 50% of the cost of exterior building restoration or renovations (total annual budget is \$15,000); a sidewalk street chalk festival; a series of ten free evening summer concerts; a spring wine and food festival; and a late summer craft beer and food showcase. While the expenses are high, the net revenue from all these activities supplements other income sources in providing the downtown maintenance, flower program, and business education aims of the Association.

Part III, Line 4a -- The flower program is a major activity of the organization despite the fact that the financial cost in 2017 was much less than normal. Due to an error in applying for a State of Washington tax credit funds, the City of Yakima purchased the hanging baskets in 2017.

This resulted in a savings to the Downtown Association of \$41,000; but was a one-time credit.

Part VI, Line 11b and Line 19 - This Form 990 was distributed to all board members via e-mail as well as being reviewed at the most recent board of trustees meeting. This form, all governing documents, financial statements, and meeting minutes are readily available upon request and such information is in the regular e-news, announced at the monthly downtown breakfast meetings, and on the website.

Line XI, Line 9 - the adjustment in net assets reflects the equity the organization has in a 2017 pick-up truck, purchased with a cash down payment and a bank loan.

Part III, Line 2 - It should also be noted that the Association took over the Downtown Maintenance program on July 1, 2017. While some such work had been done in the prior year, the extent of the responsibilities greatly increased in 2017 and will increase again in terms of cost in 2018, as the Association will run this program service the entire year.

Parts IX and X - While all figures are accurate, it should be noted that the Association had no staff or full office operation prior to May 1, 2017. The Association also, as noted above, greatly increased responsibilities for downtown maintenance effective July 1, 2017. Therefore, some expenses for office supplies, maintenance equipment, and even occupancy include some one-time start-up expenses. This includes the purchase of a truck and power lawn & garden equipment, the installation of a garage door, computers, and telephones. The report for 2018 will show more "normal" recurring expenses.
