At Global Gospel Action, our vision is to proclaim Jesus Christ to every person, in all nations, through all possible means, until He returns. Currently, our main projects are Salvation and Healing Campaigns are community changing events that bring thousands to Christ. Last year, we held 12 crusades in two countries. Motivated by our faith in Jesus Christ, we help those in extreme poverty or in a crisis situation. About 14 tons of food, roughly 35,000 books and hundreds of toys were donated along with our evangelistic efforts to the poor. Other activities we perform at Global Gospel Action are Bible distribution, school outreaches, church planting, ministry education fund, native mission fund and a social media presence with interactive teaching and provision of teaching material. Every event involves several hundred local volunteers and often several U.S. American volunteers or teams.

The organization maintains a continuous program of solicitation of funds from the general public by investing in email campaigns and social media presence, whenever an opportunity arises, we present our projects and encourage giving. However, most of our audience has a very poor background due to the international nature of most of our conferences and events in developing countries and the absolute focus of our activities on programs that further the exempt purpose of the organization rather than on fundraising. The organization has a governing body which seeks to provide Biblical teaching for as many peoples as possible, free of charge as well as humanitarian help. There is no membership fee. However, practical steps are being taken to improve fundraising on a broader base, this was discussed during the last board meeting. New board members have taken on the challenge of creating new methods for fundraising from various sources. Several churches and one foundation have started to support our ministry.
