The employees had applied for and been approved for grants to assist in paying for medical insurance benefits or other employee benefits that were previously provided to them via payroll deductions, but such benefits were in jeopardy of cancellation due to not being able to work, and due to sick-leave benefits having been exhausted. Such grants were paid directly to the employer in order to be certain the grants were used for the intended purpose. Grants in this category were paid to the employer on behalf of 366 employees, and totaled \$143,346. Swift Charities also made employee-assistance grants in 2017 that were disbursed to Swift Transportation Corporation (employer of the grant recipients) in order to deliver the grants more rapidly and efficiently to the employee (faster than the postal service) by utilizing an electronic system that the employer uses for transferring funds to employees. Grants in this category were paid to the employer on behalf of 6 employees, and totaled \$5,110. Swift Transportation Corporation is a trucking company. Jerry Moyes is an officer of the company, and is also an officer and director of Swift Charities.
