THE FOUNDATION FOR RECOVERY CONTINUES TO EXPAND THE SOUTHERN NEVADA RESOURCE DIRECTORY AS A STATE WIDE DIRECTORY, WHILE WORKING WITH AGENCIES THROUGHOUT THE STATE TO EXPAND THE LIST OF RESOURCES. THIS PUBLICATION IS REGULARLY UPDATED AND PROVIDES THE LATEST INFORMATION ON LOCAL RESOURCES FOR SUBSTANCE USE AND MENTAL HEALTH, INCLUDING RECOVERY RESOURCES IN THE COMMUNITY. IT CONTINUES TO BE A MUCH SOUGHT AFTER RESOURCE IN OUR COMMUNITY AND IS DISTRIBUTED, AT NO COST, TO NON-PROFITS, MEDICAL FACILITIES, LAW ENFORCEMENT, SOCIAL SERVICE AGENCIES, VETERAN GROUPS, COURTS, EDUCATORS AND COUNSELORS THROUGHOUT THE STATE OF NEVADA. FFR HAS FOCUSED ON UPDATING THE RESOURCES ON THE WEBSITE TO BE INCLUSIVE OF THE STATEWIDE EFFORTS FOR OUR SAMSHA GRANT. FFR WAS AWARDED A SAMSHA GRANT FOCUSED ON DEVELOPING AND SUPPORTING NEW AND EMERGING RECOVERY COMMUNITY ORGANIZATIONS ACROSS THE STATE. A MAJOR GOAL OF THE GRANT IS TO DEVELOP LEADERSHIP AMONG PEOPLE IN RECOVERY, FAMILY MEMBERS AND ALLIES TO PROVIDE A VOICE TO SUPPORT COMMUNITIES OF RECOVERY. THE TOPICS OF FOCUS INCLUDE INTEGRATION OF PHYSICAL AND BEHAVIORAL HEALTH, EDUCATION KEY RECOVERY STAKEHOLDER ORGANIZATIONS AND POLICY MAKERS TO ENSURE POLICIES AND PRACTICES ARE MOVED FORWARD IN THE STATE. THERE IS ALSO AN EMPHASIS ON STRESSING THE IMPORTANCE OF PEER RECOVERY SUPPORT FOR INDIVIDUALS IN OR SEEKING RECOVERY. THIS GRANT WAS AWARDED IN SEPTEMBER 2017 AND IS EXPECTED FOR CONTINUATION UNTIL 2020. THE FOUNDATION HOLDS WORKSHOPS AND TRAININGS FOR ADDICTION PROFESSIONALS, RESEARCHERS, EDUCATORS, STUDENTS AND OTHERS TO DISSEMINATE THE LATEST INFORMATION ON SUBSTANCE USE RESEARCH, TREATMENT AND RECOVERY. MENTAL HEALTH FIRST AID AND YOUTH MENTAL HEALTH FIRST AID ARE OFFERED AND CONTINUE TO GROW AND REACH OUT TO INDIVIDUALS AND ORGANIZATIONS THAT DEAL WITH PUBLIC CONTACT ON A DAILY BASIS. MENTAL HEALTH FIRST AID AND YOUTH MENTAL HEALTH FIRST AID ARE EVIDENCED BASED PUBLIC EDUCATION PROGRAMS THAT HELP THE PUBLIC IDENTIFY, UNDERSTAND, AND RESPOND TO SIGNS OF MENTAL HEALTH AND SUBSTANCE USE DISORDERS. WORKSHOPS HAVE BEEN EXPANDED TO INCLUDE SAFETALK (SUICIDE PREVENTION) AND "ASSIST" (APPLIED SUICIDE INTERVENTION SKILLS TRAINING) FOR BOTH PROFESSIONALS AND COMMUNITY MEMBERS TO PROVIDE A GREATER AWARENESS AND SKILLS FOR SUICIDE PREVENTION. FFR IS ONE OF ONLY TWO RECOGNIZED ORGANIZATIONS IN THE STATE OF NEVADA THAT IS APPROVED TO TRAIN PEER RECOVERY SUPPORT SPECIALISTS. AN AVERAGE NUMBER OF PARTICIPANTS THAT TAKE OUR TRAINING IS 20-25 MAXIMUM PER CLASS. THIS TRAINING IS THE ONLY IN-PERSON TRAINING FOR BUILDING SKILLS AND KNOWLEDGE OF INDIVIDUALS INTERESTED IN A CAREER OR TO VOLUNTEER AS A PEER RECOVERY SUPPORT SPECIALIST. FFR CONTINUES TO PLACE STRONG EMPHASIS ON SOCIAL MEDIA ENABLING US TO REACH A SIGNIFICANTLY LARGER NUMBER OF INDIVIDUALS AND GROUPS. OTHER OUTREACH INITIATIVES INCLUDE COMMUNITY EVENTS SUCH AS THE VETERAN'S STAND DOWN, WELLNESS FAIRS, AND COLLABORATIONS WITH COMMUNITY COALITIONS AND MULTIPLE NON-PROFIT, GOVERNMENT, LAW ENFORCEMENT, EDUCATION AND SOCIAL SERVICES AGENCIES, SOUTHERN NEVADA MENTAL HEALTH COALITION, SPECIALTY COURT JUDGES, VETERAN'S GROUPS, NEVADA SUBSTANCE ABUSE PREVENTION AND TREATMENT AGENCY, NEVADA'S BEHAVIORAL HEALTH PLANNING AND ADVISORY COUNCIL, AND NEVADA'S MULTIDISCIPLINARY PREVENTION ADVISORY COUNCIL AND THE STATEWIDE PREVENTION COALITIONS. THE FOUNDATION FOR RECOVERY HOUSES A LARGE SELECTION OF RECOVERY RELATED MEMORABILIA FOR VIEWING AND USE BY THE GENERAL PUBLIC WITH INTEREST IN THE HISTORY OF RECOVERY OR RECOVERY RESEARCH. THE FOUNDATION IS COMMITTED TO THE PRESERVATION OF THE PIECES IN THE COLLECTION AS WELL AS RESTORATION OF OLDER PIECES. THE ARCHIVE IS HOUSED IN A CLIMATE CONTROLLED ATMOSPHERE TO MAINTAIN THE INTEGRITY OF EACH PIECE. CONTINUING EMPHASIS IS PLACED ON CATALOGING THE INDIVIDUAL COLLECTIONS THAT MAKE UP THE ARCHIVE. THE ARCHIVE CONTAINS THOUSANDS OF INDIVIDUAL PIECES TRACING THE RICH HISTORY OF NATIONAL AND INTERNATIONAL RECOVERY MOVEMENTS, OFFERING A WEALTH OF ORIGINAL SOURCE INFORMATION TO RESEARCHERS.
