Haiti Relief and Bible Training Center. Through the operation of the Haiti Bible Training Center and extended campus our core function in Haiti is to bring in young leaders from different provinces of Haiti in order to build them up in the Word of God, taking them through the bible over the course of two years and send them back out to plant churches in order to provide bible teaching discipleship and community relief throughout the entire country. Each church plant is a community center where assistance to the poor, homeless, widows and orphans of Haiti are given relief aid. At the church facilities, in addition to the bible teaching and discipleship we dig deep water wells, provide medical supplies and assistance and distribute relief aid - all free of cost to the Haitian people. In 2017 Cross to Light sponsored 4 student scholarships at the training center, supported 9 church plants, conducted 120 outreach events, completed 3 water projects, hosted over 200 missionary volunteers in Haiti distributing over 10,200 pounds of relief aid to the people of Haiti, helped improve 9 communities, held 5 free medical day clinics, held 7 prison outreaches with supply assistance, conducted 3 group weddings, distributed over 5,004 Bibles, provided skills training such as carpentry and gardening, fed clothed, and ministered to thousands of children through children's feeding and vacation Bible school outreach events.
