THE FAMILY ADVOCACY CENTER'S GOALS ARE TO KEEP CHILDREN SAFE AND STABLE WITHIN THEIR FAMILIES, MINIMIZE THE EMOTIONAL TRAUMA CAUSED BY REMOVAL AND FOSTER CARE PLACEMENT, AND ALLOW THE FOSTER CARE SYSTEM TO FOCUS ITS RESOURCES ON CHILDREN WHO NEED ITS PROTECTION. USING A MULTI-DISCIPLINARY TEAM (TWO ATTORNEYS, A SOCIAL WORKER, AND A PARENT ALLY), THE FAMILY ADVOCACY CENTER WORKS TO KEEP FAMILIES TOGETHER BY STRENGTHENING A CARETAKER'S ABILITY TO PROVIDE FOR A CHILD'S SAFETY, STABILITY, AND PERMANENCE. SINCE 2016, THE FAMILY ADVOCACY CENTER HAS PROVIDED LEGAL SERVICES TO MORE THAN 80 FAMILIES. EXECUTIVE AND STAFF SUPPORT FOR THE WASHINGTON STATE COMMISSION ON CHILDREN IN FOSTER CARE IS PROVIDED BY CCYJ. LAWYERS FOSTERING INDEPENDENCE (LFI) WAS LAUNCHED BY CCYJ IN 2008. LFI IS THE ONLY CIVIL LEGAL AID PROGRAM IN WASHINGTON STATE FOCUSED ON SERVING CURRENT AND FORMER FOSTER YOUTH AGES 17-25. LFI ALSO SERVES YOUTH WHO HAVE BEEN OR ARE AT RISK OF BECOMING HOMELESS. CURRENTLY SERVING KING AND SNOHOMISH COUNTIES, LFI CONNECTS THESE YOUNG ADULTS WITH ATTORNEYS WHO PROVIDE FREE LEGAL SERVICES TO HELP THEM REACH FOR THEIR FUTURE WITHOUT BEING BLOCKED BY THEIR PAST. LFI VOLUNTEER ATTORNEYS HELP YOUTH TO ADDRESS BARRIERS TO EMPLOYMENT, EDUCATION, HOUSING STABILITY, AND SUCCESSFUL PARENTING. IN 2017, LFI PROVIDED DROP-IN LEGAL CLINICS FOR YOUTH, TRAINING OPPORTUNITIES FOR VOLUNTEER ATTORNEYS, AND SERVED MORE THAN 200 YOUTH.
