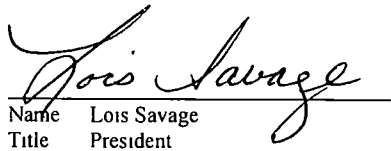

B. Timely Satisfaction of Minimum Distribution Requirement for the Taxable Year following the Conduit Election Year. As reported on Part XIII, Line 6f, column (d), the undistributed income for the Conduit Election Year is \$0. In other words, the Foundation had no undistributed income for 2017.

C. Sufficient Timely Qualified Distributions Made Out of Corpus.
