Nonprofit VOTE worked in 2017 to engage nonprofits on voting and elections. Our monthly webinars reached over 2,000 nonprofit staff and leaders with legal how-to's, best practices, and planning tools. We updated our online resource library to reflect current law and best practices. In spring, we released our America Goes to the Polls report ranking all 50 states in voter turnout to assess the effectiveness of public policies, like Election Day Registration, at increasing turnout. The report was widely covered in the media with stories in the New York Times, The Hill, Politico, American Prospect, and over 70 state and local outlets. Through our States Program, we worked with partners across 5 states to register or pledge to vote 7,000 individuals. Meanwhile, we analyzed the data from our 9-state 2016 program to document the impact of nonprofits doing voter engagement. Finally, we recruited over 400 nonprofit partners for National Voter Registration Day.

National Voter Registration Day (NVRD), a collaborative initiative managed and fiscally sponsored by Nonprofit VOTE, is a single day of coordinated media and field actions aimed at raising awareness of voter registration opportunities and registering as many voters as possible. It is held on the 4th Tuesday of each September. Expenses include recruitment of over 40 major national "Premier" and 2,850+ community partners in the lead-up to the 2017 NVRD. We provided online resources i.e. field & communication toolkits as well as legal guides to organizing voters registration drives. We hosted 2 webinars that drew over 700 attendees between them. Partners received packets of posters & stickers. Costs include post-event data collection, reporting & evaluation as well as initial planning for 2018.

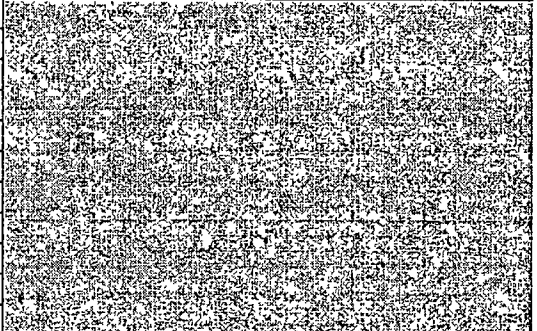
