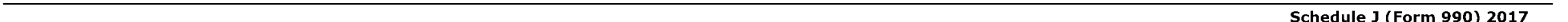

World Vets started providing veterinary services for marine mammal stranding cases in Washington state. Dr. Cathy King is the primary veterinary responder for field calls, consultations and in-clinic veterinary services (in addition to all normal organizational responsibilities). Dr. King is also on 24/7 emergency call for marine stranding work which has substantially increased her workload. Rather than hire an additional veterinarian to take on the workload, Dr. King has substantially increased her weekly workload bringing a cost savings to the organization while increasing our level of program services to animals in need of veterinary care.
