NECESSITY OF EACH SUCH REQUEST FOR FINANCIAL STATEMENTS AND POLICY
DOCUMENTS AND TO DETERMINE, IN ITS SOLE DISCRETION, WHETHER TO RELEASE
THESE DOCUMENTS TO AN OUTSIDE PARTY.
