THE SOCIETY IS A MEMBER OF THE ORNITHOLOGICAL SOCIETIES OF NORTH AMERICA (OSNA) AND A CONTRIBUTING MEMBER OF MANY OTHER SCIENTIFIC SOCIETIES WORLDWIDE, INCLUDING AMERICAN BIRD CONSERVANCY AND THE ORNITHOLOGICAL COUNCIL.
