COUNTED IN DETERMINING THE EXISTENCE OF A QUORUM. THE MINUTES

OF THE MEETING SHALL REFLECT THE DISCLOSURE, THE ABSTENTION

FROM VOTING, AND THE PRESENCE OF QUORUM OR ABSENCE THEREOF.

IN ADDITION, THE BOARD WILL REQUIRE A SIGNED STATEMENT FROM EACH

DIRECTOR ON AN ANNUAL BASIS INDICATING ANY CONFLICT OF INTEREST

THAT MIGHT BE IN EXISTENCE OR THE FACT THAT THERE IS NO CONFLICT

OF INTEREST.
