A COMMITTEE IS MAINTAINED ON OPEN ACCESS TO GOVERNMENTAL RECORDS COMPOSED OF A CHAIRPERSON AND SIX MEMBERS FROM THE UNITED STATES, CANADA, AND OTHER NATIONS. THE COMMITTEE COMMUNICATES BY TELEPHONE, EMAIL, AND POSTAL MAIL. THE MEMBERS OF THE COMMITTEE PAY THEIR OWN COSTS. IT IS ESTIMATED THAT THE TOTAL COSTS OF THE COMMITTEE DO NOT EXCEED \$200 PER YEAR. IT IS ESTIMATED THAT THE MEMBERS OF THE COMMITTEE EACH SPEND APPROXIMATELY 10 HOURS PER WEEK ON THE SUBJECT MATTER.
