The Foundation's only purpose since its incorporation, by way of annual gifts, has been to fund special projects as proposed by the Elisabeth Morrow School, for faculty support in addition to funding the School's scholarship and endowment projects. Currently several members of the Foundation's Board have significant relationships with the School as a former trustee, a former teacher, parents, and a spouse of a trustee of the School. Board members meet with the Head of School three or more times a year to discuss the School's priorities. Each year the Head of School presents the Foundation with recommendations of items for financial support and amounts requested.
