The Fund makes grants to support research in topics relevant to the mission of the NBME. The initial sum of \$5,000,000 was invested and professionally managed with the goal of increasing the size of the Fund over time while providing total annual grants up to 5% of the trailing three-year average of the fund balance. As with all NBME invested funds, the Finance Committee monitors performance and recommends to the Executive Board any changes to the principal balance of the Fund. THE STRATEGIC EDUCATOR ENHANCEMENT FUND OF NBMEIn 2017, NBME established the Strategic Educator Enhancement Fund to provide opportunities of value to the community from which NBME obtains volunteers and other stakeholders. The initial amount of \$20,000,000 was designated within NBME's investments as a quasi-endowment fund. The maximum annual authorized disbursement from the quasi-endowment fund for 2017 through 2019 is an average of \$600,000 per year. Beginning in 2020, the maximum annual disbursement in any year will be equal to 5% of the average of the trailing three-years ending balance of the investments.

NBME had unrelated business taxable income of \$48,000 for the year ended December 31, 2017 and incurred a loss of \$29,000 for the year ended December 31, 2016 associated with the operation of debt-financed commercial rental property. Accordingly, NBME has a related net operating loss carryforward of \$1,464,000 and \$1,512,000 as of December 31, 2017 and 2016, respectively, expiring between December 31, 2028 and 2037. In addition, NBME has a deferred tax asset of \$307,000 and \$514,000 as of December 31, 2017 and 2016, respectively, which has been fully reserved due to the uncertainty of the realization of these losses. The deferred tax asset as of December 31, 2017 reflects a reduction of \$193,000 associated with a lower income tax rate of 21% pursuant to the provisions of the Tax Cuts and Jobs Act of 2017. NBME has no uncertain tax positions and there are no accruals for interest or penalties in the accompanying consolidated financial statements. Management believes that NBME is no longer subject to income tax examinations for years ended on or prior to December 31, 2013. (Amounts in the FIN 48 footnote for 2017 were slightly modified subsequent to issuance of audited financial statements.)
