EACH NOT-FOR-PROFIT ORGANIZATION IS ASSIGNED AN EXEMPTION CODE BY INTERNAL REVENUE SERVICE, AND EACH CHARITABLE ORGANIZATION IS FURTHER CATEGORIZED BY A PUBLIC CHARITY STATUS. THE STATUS SUMMARIZES HOW AN ORGANIZATION RECEIVES ITS SUPPORT. THE PUBLIC CHARITY STATUS IS COMMONLY REPRESENTED BY A LINE NUMBER AS IS SHOWN IN PART II ABOVE. IF DESIRED, A BRIEF DESCRIPTION FOR EACH LINE MENTIONED IS AVAILABLE ON SCHEDULE A, PAGE ONE.
