As project management organization, it partners with arts & cultural institutions, artists and creative individuals to extend their reach by developing and deliver programs to under-resourced communities and populations across the United States.

Producing & Delivering Discovery: As an arts and creative project management organization, Artrain partners with arts and cultural institutions, artists and creative individuals to develop and deliver programs in all the art and creative disciplines, culture, history, science, environment, etc. Artrain has shared its award-winning programs with people across the USA and Canada. Since its founding in 1971, Artrain has helped start or strengthen hundreds of cultural organizations.. In recognition of its legacy, Artrain received the National Medal for Museum Service, the nation's highest award for museums, n 2006. Artrain's services include project management of exhibition and programs from concept through fabrication and installation – including education programs and catalogues; public relations and marketing; program and/or tour delivery; fundraising programs; and administration and financial management.

A self-produced project of Artrain's, Creative Voice, earned its third National Endowment for the Arts (NEA) grant in 2017. It is a media-based arts journalism source that produces and posts video stories about arts and cultural events in Detroit and SE MI on social media. Creative Voice highlight reels, in addition to being made and shared FREE to arts and cultural organizations for their use, are posted immediately to YouTube and other social media sites for sharing.

2. Arts & Creative Education – Artrain's programming has always included arts and creative education for the intrinsic value plus the measured outcomes of such education. In 2017 Artrain concluded its national award-winning multi-year Paths to Peace project in partnership with the National Parks Service (NPS). This international exchange program used the arts to teach about the War of 1812 from three perspectives: the United States, the British/Canadian and the First Nations/American Indians. In development for a number for a number of years, this project faced its own unique set of predicaments outside of Artrain's control. Artrain navigated through Artrain navigated through NPS personnel changes, school teacher strikes and border crossings legalities. Eventually, more than 300 eighth-grade students and teachers from Ypsilanti, Michigan and Windsor, Ontario, Canada, as well as a dozen teaching artists, park park rangers from the National Park Service and Parks Canada plus Artrain staff and volunteers were involved. Students wrote and and recorded songs, created artwork and performed dances. A highlight was the quilt made by the Ypsilanti Community Middle eight graders, entitled "Paths to Peace" and gifted to the NPS Perry's Victory and International Peace Memorial site in Put-in-Bay, Ohio for their permanent collection.

1. Strengthening Nonprofits, Building Capacity and Making Creative Dreams Come - Artrain remains committed to strengthening and building capacity for nonprofit arts and cultural organizations through fiscal sponsorships and or administrative contracts. Artrain is contracted by The Arts Alliance, a local arts agency that champions, supports and advocates for the arts and creative industries in the greater Ann Arbor, MI area to managing its administrative, development and program efforts. Projects highlights 1) A multi-phased Washtenaw County Creative Center Assessment Report on the possibilities for one or more multi-tenant, multi-use artist center and 2) an education initiative intended to insure that all 47,000 students in the county have equitable access to excellent arts and creative education.

Artrain is also the fiscal sponsor to a number of creative projects including:  
- A2 JAZZ FEST- A free two-day festival that brings multiple generations of local jazz artists together with a supportive community.  
- The Bob Ufer Story a documentary film celebratatin the life of legendary University of Michigan football announcer Bob Ufer.  
- Commie High: The Film, a documentary film about one of the longest-running alternative public schools in America – Ann Arbor's Community High School
