The Akron Children's Hospital Foundation works to ensure that the Hospital (CHMCA) can continue to uphold its three promises 1) treat each other the way we would want to be treated 2) treat each child as if it were our own 3) turn no child away for any reason During 2017, CHMCA broke ground on a 230,000 square foot addition to the Considine Professional Building The new building will bring together all of our outpatient clinics on the Akron campus and continue the campus transformation the hospital began in 2012 when it broke ground on the Kay Jewelers Pavilion, which opened in 2015 The Considine Professional Building expansion space will be designed to be more flexible, collegial and diverse The expansion project will nearly double the existing square footage of the building, and total 480,000 square feet when it's complete The expansion project will help meet the growing need for more space in the Neurodevelopmental Science Center and Sports Medicine In addition, the outpatient pharmacy will move into the larger renovated space The biggest change with the expansion and combining all the out-patient clinics in one building will be the centralized check-in and registration process This centralized registration will allow for faster access to patient services The building will also feature amenities for families including a caf Philanthropy plays a key role in the success of the campus expansion The Kay Jeweler's Pavilion ("KJP") was opened in May 2015 and approximately \$30,000,000 was raised by the Foundation to offset the costs of construction During 2017, an additional amount of \$250,000 was raised for the Considine Professional Building expansion During 2017, an additional amount of \$4,804,887 Foundation funds were used by CHMCA to support its mission Of that amount, additional support also went for the following programs \$744,772 Hematology/Oncology, \$481,411 Akron Marathon, \$461,515 Global Health, \$345,000 Palliative Care, \$291,110 Research and Education, \$259,000 Regional Burn Center, \$246,658 Safety and Injury Prevention, \$185,000 Child Advocacy, \$154,700 Reach Out and Read Program, and \$82,000 Kohl's Youth Fitness which supports CHMCA's fitness program for the youth in the surrounding communities The remaining amount was used for patient care and support programs including Neonatal, Pediatrics, Tele-Health Mental, Outreach, and other programs Since the Foundation's creation, it has provided the sources to purchase specialized lifesaving medical equipment which might not have otherwise been possible within CHMCA's budget limitations The Foundation has financed medical research into the cause, prevention and treatment of complex childhood diseases and problems, and has provided community safety programs in professional education, patient information and youth development The net effect of these efforts has been to keep CHMCA at the forefront of healthcare, while minimizing the cost of such care to patients and their families
