ACCORDING TO THE 2015-2016 RIO ARriba COMMUNITY HEALTH PROFILE, MENTAL HEALTH AND SUBSTANCE ABUSE-RELATED PROBLEMS LEAP TO THE FORE AS THE SINGLE MOST PRESSING THREAT TO THE HEALTH OF RIO ARriba RESIDENTS.
