**"The Boys Who Said No" - production of a documentary film about opposition to the draft during the Vietnam War. When released, thousands of people will view the film and learn about an important historical moment in American history. The film may also be used as part of a peace or nonviolence education curriculum.**

**Resource Center for Nonviolence Program. The Center provides information regarding the philosophy and practice of nonviolence by offering educational programming through activities such as workshops, presentations, films, and printed or digital information. RCNV programs have an estimated 3,300 visits per year, and serve approximately 600 people. (These numbers are based on a one year period starting September 15, 2017, prepared for a grant report. We feel these numbers are representative of annual program accomplishments, which remain fairly steady year to year.) RCNV also has a youth program working in the schools and through independent events to promote nonviolence and civic engagement, which included dozens of presentations and events, engaging several hundred youth.**

**Resource Center for Nonviolence Community Center. In addition to its direct program contributions in support of nonviolence, the Resource Center for Nonviolence also operates a community center that serves as a resource for dozens of organizations and hundreds of visitors, for low cost or sometimes no cost (donated space for events and groups with limited funds). RCNV Community Center facility has an estimated 9,500 visits per year, serving approximately 4,000 people, and providing space to 97 different organizations for meetings and public programs. (These numbers are based on a one year period starting September 15, 2017, prepared for a grant report. We expect these numbers to be representative of annual use, which has increased steadily since a major building remodel.)**
