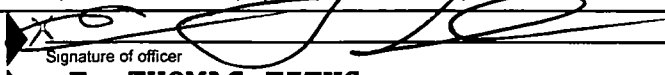

RESOLVED, that the corporation's articles of incorporation shall be amended by the restatement of article FIRST and article SIXTH to read as follows:

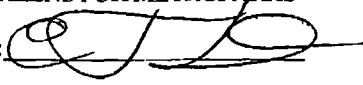
FIRST: The name of said corporation shall be "METROPARKS TOLEDO FOUNDATION."
