Grant applications are available each year in late July, and must be submitted by mid-September. Applications are then reviewed by the Interest on Lawyers Trust Accounts (IOLTA) Grants Committee. The Committee recommends grant awards based on the above criteria. The Foundation Board of Directors approves final grant awards at the October Board Meeting. Grant recipients are required to sign a contract which specifies how the grant is to be expended, and the subsequent reporting requirements.
