THE ARMY HERITAGE CENTER FOUNDATION CONTINUED ITS EFFORTS IN 2017 TO ADVANCE THE DEVELOPMENT OF THE U.S. ARMY HERITAGE AND EDUCATION CENTER (USAHEC), TO PROMOTE THE CENTER AS A TOURIST DESTINATION, AND TO ENHANCE ITS PROGRAMS AND OUTREACH. THE FOUNDATION CLOSED OUT THE CONSTRUCTION OF THE FIRST PHASE OF THE HALL OF THE AMERICAN SOLDIER TRANSFERRING BENEFICIAL OCCUPANCY TO THE ARMY IN OCTOBER 2016 AND FORMAL OWNERSHIP IN FEBRUARY 2017. IN MAY 2017, THE FOUNDATION RECEIVED A PROGRAM AUDIT FROM THE PENNSYLVANIA OFFICE OF THE BUDGET TO VALIDATE THAT ALL EXPENSES MET THE REDEVELOPMENT ASSISTANCE CAPITAL PROGRAM (RACP) GUIDELINES. NO DEFICIENCIES WERE NOTED. DURING THE SAME PERIOD, THE FOUNDATION COORDINATED WITH THE STAFF OF USAHEC ON THE PLANS FOR THE FUTURE EXPANSION OF THE HALL OF THE AMERICAN SOLDIER. THIS PHASE, WHICH WILL COMPLETE THE BUILDING, WILL ADD 30,000 SQUARE FEET TO THE FACILITY AND MEETS USAHEC'S NEED FOR ADDITIONAL EXHIBIT AND EDUCATIONAL PROGRAM SPACE. THE COMMANDANT OF THE U.S. ARMY WAR COLLEGE APPROVED THE DESIGN CONCEPT IN JULY 2017. ESTIMATED COST OF THIS EXPANSION IS \$11.5 TO 12 MILLION. THE FOUNDATION IS CURRENTLY DEVELOPING A CAPITAL CAMPAIGN PLAN TO MEET THIS NEED OF THE ARMY. THE FOUNDATION EXPENDED \$19,200 IN 2017 IN SUPPORT OF CONSTRUCTION RELATED ACTIVITIES. THE FOUNDATION CONTINUED TO PROMOTE USAHEC AS A DESTINATION. DURING THE YEAR, THE FOUNDATION PURCHASED ADVERTISING AND MARKETING MATERIALS IN REGIONAL TOURISM MAGAZINES AND OTHER MEDIA OUTLETS. IN SUPPORT OF ARMY HERITAGE DAYS, USAHEC'S LARGEST PUBLIC EVENT, THE FOUNDATION PURCHASED A DIGITAL BILLBOARD AND FUNDED A RADIO ADVERTISING CAMPAIGN AND A TARGETED FACEBOOK ADVERTISING PROGRAM THAT REACHED OVER 300,000 INDIVIDUALS. TO BETTER MARKET USAHEC TO THE TRAVELING PUBLIC, THE FOUNDATION PURCHASED ADVERTISING ON AN APP THAT ALLOWS TRAVELERS ON I-81 TO GAIN INFORMATION AS THEY TRAVEL THROUGH THE REGION. FINALLY, THE FOUNDATION STAFF CONTINUED TO SUPPORT PROGRAMS AND EVENTS WHEN FEDERAL EMPLOYEES WERE UNAVAILABLE. THE FOUNDATION EXPENDED \$12,983 IN 2017 TO PROMOTE USAHEC AS A DESTINATION. THE FOUNDATION ALSO SUPPORTED EFFORTS TO ENHANCE USAHEC PROGRAMS AND OUTREACH. IN 2017, THE FOUNDATION FUNDED THE COPYRIGHT PERMISSIONS FOR TWO PUBLIC SHOWINGS OF FILMS AND SERVED AS THE COORDINATOR OF A PARTNERSHIP THAT INCLUDED USAHEC AND WITF PUBLIC TELEVISION AND RADIO FOR THE PREVIEW OF KEN BURNS' VIETNAM WAR DOCUMENTARY. TO HIGHLIGHT USAHEC'S COLLECTIONS, THE FOUNDATION PARTNERED WITH CUMBERLAND COUNTY HISTORICAL SOCIETY'S CUMBERLAND PATHWAYS GENEALOGY CONFERENCE AND PROVIDED STAFF TO SUPPORT PANEL DISCUSSIONS ON THE USE OF MILITARY RECORDS FOR GENEALOGICAL RESEARCH. TO REACH THE MILLENNIAL GENERATION, THE FOUNDATION HOSTED A LIVE WEB BROADCAST OF NO THINGS CONSIDERED ON THE DAILY CALLER NETWORK. THE FOUNDATION ALSO PROGRAMMED ITS OWN SPECIAL EVENTS TO HIGHLIGHT USAHEC. THESE INCLUDED THE SHOWING OF THE DOCUMENTARY BEYOND MILITARY MEDICINE WITH AN EXPERT PANEL THAT HIGHLIGHTED MILITARY MEDICAL IMPROVEMENTS DURING THE PAST 15 YEARS. AS A FOLLOW-ON PROGRAM TO THE BURNS DOCUMENTARY, THE FOUNDATION HOSTED A PANEL DISCUSSION THAT EXPLORED THE CONCEPT OF MORALE INJURY AND ALLOWED MANY VIETNAM VETERANS TO DISCUSS THEIR REACTION TO THE KEN BURNS FILM. IN JUNE, THE FOUNDATION HOSTED THE REGIONAL ARMY BIRTHDAY DINNER AT THE U.S. ARMY HERITAGE AND EDUCATION CENTER AND IN NOVEMBER, AGAIN AT THE CENTER, THE ANNUAL MEMBERSHIP RECOGNITION DINNER THAT HIGHLIGHTED THE SERVICE OF VIETNAM VETERAN BILL BECK AND JOE GALLOWAY, WHO DOCUMENTED THEIR SERVICE AS A REPORTER AND AS AN AUTHOR. THE FOUNDATION CONTINUED ITS ACTIVE ROLE WITH POTENTIAL DONORS OF ARTIFACT, MANUSCRIPT, AND LIBRARY COLLECTIONS. IN 2017, THE FOUNDATION FACILITATED MORE THAN 150 "IN KIND" DONATIONS. MAJOR COLLECTIONS ACQUIRED INCLUDED ADDITIONAL ARTIFACTS AND MANUSCRIPT MATERIALS RELATED TO MATTHEW BATSON AND MORE THAN 200 ADDITION DRAWINGS BY KOREAN WAR VETERAN JOHN A. COOK. AT THE END OF THE YEAR, MORE THAN AN ADDITIONAL DOZEN COLLECTIONS WERE PENDING ACCEPTANCE BY THE ARMY. IN ALL AREAS, THE FOUNDATION EXPENDED \$11,688 IN 2017 IN SUPPORT OF USAHEC. THE EDUCATION DEPARTMENT'S PROGRAMS CONTINUED TO ENHANCE USAHEC'S EDUCATIONAL MISSION THROUGH PROMOTING THE STUDY OF HISTORY AND OUTREACH TO STUDENTS, TEACHERS, AND MEMBERS OF THE PUBLIC ON A LOCAL, REGIONAL, AND NATIONAL BASIS. THE MAJOR OUTREACH PROGRAM IN 2017 WAS AGAIN THE FOUNDATION'S MANAGEMENT OF THE NATIONAL HISTORY DAY IN PENNSYLVANIA (NHD IN PA) PROGRAM. IN 2017, MORE THAN 12,000 STUDENTS AND 300 TEACHERS THROUGHOUT PENNSYLVANIA PARTICIPATED. THE FOUNDATION PROVIDED SUPPORT TO OUR REGIONAL PARTNERS AND MANAGED THE STATEWIDE COMPETITION THAT ENGAGED MORE THAN 1,100 STUDENTS, TEACHERS, PARENTS, AND VOLUNTEERS IN THE EXPLORATION OF HISTORY. SIGNIFICANT NUMBERS OF NHD IN PA STUDENTS CONTINUE TO VISIT USAHEC TO UTILIZE THE COLLECTION FOR THEIR RESEARCH. IN 2017, THE FOUNDATION CONTINUED TO DEVELOP WAYS TO EXPAND ITS INTERACTION WITH VETERANS. THE FOUNDATION DEVELOPED A "WALK WITH A VETERAN" PROGRAM THAT PAIRED VETERANS WITH STUDENTS FOR A DAY LONG DISCUSSION OF MILITARY SERVICE AND ITS MEANING AND IMPACT ON THE HISTORY OF THE NATION. MORE THAN 250 STUDENTS AND VETERANS PARTICIPATED IN THIS PROGRAM. THE VETERANS' CAFE, WHICH BEGAN IN 2016, CONTINUED TO GROW WITH BI-MONTHLY EVENTS THROUGHOUT THE REGION. THIS PROGRAM BRINGS TOGETHER VETERANS OF ALL SERVICES AND ERAS TO ENJOY A MEAL TOGETHER AND SHARE STORIES OF SERVICE. SELECTED ATTENDEES ARE THEN HIGHLIGHTED, AND THOSE WHO HAVE UNIQUE STORIES OF SERVICE ARE ASKED TO PARTICIPATE IN THE ORAL HISTORY PROGRAM THAT THE FOUNDATION HAS MANAGED INCLUDING THE VETERANS ORAL HISTORY PROJECT (VOHP) THAT INCLUDES STUDENTS FROM CUMBERLAND VALLEY HIGH SCHOOL. FINALLY, THE FOUNDATION CONTINUED TO HOST BOTH ITS SUMMER CAMP AND ITS QUARTERLY TEACHER WORKSHOP PROGRAMS. THE MOST NOTABLE PROGRAMMING ADDITION IN 2017 WAS AN EXAMINATION OF THE HOLOCAUST AND THE U.S. ARMY'S ROLE LIBERATING THE DEATH CAMPS AT THE END OF WWII. IN THE SEPTEMBER 2017 PROGRAM, PARTICIPANTS INCLUDED THE LAST LIVING SURVIVOR OF PENIC DEATH CAMP AND THE ARMY NURSE WHO PROVIDED IMMEDIATE MEDICAL CARE WHEN THE CAMP WAS LIBERATED. THE PROGRAM WAS LIVE BROADCAST OVER THE WEB. EFFORTS THAT ENHANCED THE VISITOR EXPERIENCE AT THE USAHEC AND PUBLIC UNDERSTANDING OF ARMY CONTRIBUTIONS CONTINUED. THE MUSEUM STORE ENDEAVORED TO TAILOR MERCHANDISE SUPPORT SPECIAL PROGRAMS AND THE CLIENTELE WHILE CONTROLLING OPERATIONAL COSTS. SALES INCREASED FROM 2016. THEIR EFFORTS SUPPORTED BOTH VISITORS AND STAFF AND PROVIDE A SMALL BUT VITAL INCOME TO THE FOUNDATION. TO EXPLORE NEW OPPORTUNITIES TO ENHANCE THE PUBLIC'S UNDERSTANDING OF THE ARMY, THE FOUNDATION PARTNERED WITH NW EUROPEAN STUDY TOURS TO DEVELOP AND HOST A NORMANDY BATTLEFIELD TOUR PROGRAM. THE PROTOTYPE TEST TOUR, CONDUCTED IN SEPTEMBER 2017, WAS SUCCESSFUL AND PLANS TO CONTINUE TO GROW THE PROGRAM WERE INITIATED. INCOME DURING THE YEAR FROM ALL SOURCES WAS \$1,240,361 AND EXPENSES WERE \$772,475. THE FOUNDATION ENDED 2017 WITH CASH RESERVES AND BOARD DESIGNATED AND RESTRICTED ACCOUNTS OF \$964,384. OUTREACH TO OUR MEMBERSHIP AND LOCAL SUPPORTERS AND THEIR BACKING OF SPECIAL EVENTS CONTINUED TO PROVIDE THE GREATEST SUPPORT TO THE FOUNDATION'S OPERATIONS. CONTRIBUTIONS OF BOTH GREW SLIGHTLY FROM 2016.

IN SUPPORT OF ARMY HERITAGE DAYS, USAHEC'S LARGEST PUBLIC EVENT, THE FOUNDATION PURCHASED A DIGITAL BILLBOARD AND FUNDED A RADIO ADVERTISING CAMPAIGN AND A TARGETED FACEBOOK ADVERTISING PROGRAM THAT REACHED OVER 300,000 INDIVIDUALS. TO BETTER MARKET USAHEC TO THE TRAVELING PUBLIC, THE FOUNDATION PURCHASED ADVERTISING ON AN APP THAT ALLOWS TRAVELERS ON I-81 TO GAIN INFORMATION AS THEY TRAVEL THROUGH THE REGION. FINALLY, THE FOUNDATION STAFF CONTINUED TO SUPPORT PROGRAMS AND EVENTS WHEN FEDERAL EMPLOYEES WERE UNAVAILABLE. THE FOUNDATION EXPENDED \$12,983 IN 2017 TO PROMOTE USAHEC AS A DESTINATION. THE FOUNDATION ALSO SUPPORTED EFFORTS TO ENHANCE USAHEC PROGRAMS AND OUTREACH. IN 2017, THE FOUNDATION FUNDED THE COPYRIGHT PERMISSIONS FOR TWO PUBLIC SHOWINGS OF FILMS AND SERVED AS THE COORDINATOR OF A PARTNERSHIP THAT INCLUDED USAHEC AND WITF PUBLIC TELEVISION AND RADIO FOR THE PREVIEW OF KEN BURNS' VIETNAM WAR DOCUMENTARY. TO HIGHLIGHT USAHEC'S COLLECTIONS, THE FOUNDATION PARTNERED WITH CUMBERLAND COUNTY HISTORICAL SOCIETY'S CUMBERLAND PATHWAYS GENEALOGY CONFERENCE AND PROVIDED STAFF TO SUPPORT PANEL DISCUSSIONS ON THE USE OF MILITARY RECORDS FOR GENEALOGICAL RESEARCH. TO REACH THE MILLENNIAL GENERATION, THE FOUNDATION HOSTED A LIVE WEB BROADCAST OF NO THINGS CONSIDERED ON THE DAILY CALLER NETWORK. THE FOUNDATION ALSO PROGRAMMED ITS OWN SPECIAL EVENTS TO HIGHLIGHT USAHEC. THESE INCLUDED THE SHOWING OF THE DOCUMENTARY BEYOND MILITARY MEDICINE WITH AN EXPERT PANEL THAT HIGHLIGHTED MILITARY MEDICAL IMPROVEMENTS DURING THE PAST 15 YEARS. AS A FOLLOW-ON PROGRAM TO THE BURNS' DOCUMENTARY, THE FOUNDATION HOSTED A PANEL DISCUSSION THAT EXPLORED THE CONCEPT OF MORALE INJURY AND ALLOWED MANY VIETNAM VETERANS TO DISCUSS THEIR REACTION TO THE KEN BURNS FILM. IN JUNE, THE FOUNDATION HOSTED THE REGIONAL ARMY BIRTHDAY DINNER AT THE U.S. ARMY HERITAGE AND EDUCATION CENTER AND IN NOVEMBER, AGAIN AT THE CENTER, THE ANNUAL MEMBERSHIP RECOGNITION DINNER THAT HIGHLIGHTED THE SERVICE OF VIETNAM VETERAN BILL BECK AND JOE GALLOWAY, WHO DOCUMENTED THEIR SERVICE AS A REPORTER AND AS AN AUTHOR.
