Criminal Justice: Through its Criminal Justice initiative, the Southern Coalition for Social Justice (SCSJ) tackles racial discrimination at the legal and policy levels to eliminate obstacles facing those with criminal records as they attempt to re-enter the mainstream of society, and engages in criminal justice impact litigation. In addition, the Youth Justice Project seeks to end the criminalization of youth through interventions in the juvenile justice and education systems.

Voting Rights: SCSJ's voting rights work protects the rights of communities of color by defending the Voting Rights Act through fair redistricting and minimizing elections administration practices that threaten free democratic participation in elections such as photo ID requirements, restrictions on voter registration and early voting and Election Day voter challenges.

Human Rights: Using a community-lawyering model, SCSJ levels the playing field to protect the civil, economic, and political rights in priority areas that are defined by the communities SCSJ seeks to serve. SCSJ will take on cases under the general rubric of Human Rights if they meet certain criteria and promise broad impact.
