schools run from baby class to 8th grade. We also maintain a secondary school in Gong. Together, we educate just under 1,000 kids
this past year. We also maintain an orphanage for the kids that go to our school but that don't have families.

an industrial kitchen. We purchased 8 shacks in South B slum, which we are planning to build a permanent school.
