Weekly and monthly meetings were held as follows: Life Skills for guys and girls, English Club, Graduate Club, Legal consultations, Young Mom's Club, Cooking classes, Creative classes, Communications club, Pregraduate counseling, Staff leadership training, and Thai boxing. The organization also expanded staff and programs based in the "Dream Center", a space for orphan/graduate activities.
