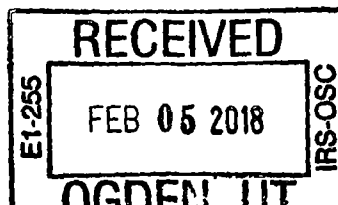

The MASSB Foundation provides financial support for social service programs that complement the efforts of Maryland-based departments of social services, by funding programs that either protect at-risk children and adults, or that preserve families, in each case mainly through providing emergency financial assistance (such as to provide heat or to avoid eviction), job training, or counseling (or facility support) focused on child protection, family reunification, or parental (or caregiver) education and support.

During 2017, a component fund of the MASSB Foundation (Calvert Family Advocates) provided services for vulnerable residents of Calvert County, Maryland, with such services mainly involving: programs to support disadvantaged and at-risk youths (\$16,360), transportation to and from work, medical appointments, and other necessary meetings, for low-income adults who otherwise had no transport due to Calvert County's rural location (\$45,130); housing assistance for at-risk families (\$11,000); rental assistance for such families (\$9,168); support services for at-risk elderly (\$6,109); emergency support for vulnerable families, such as expenses to secure heat or obtain medical supplies (\$5,161); and educational job training assistance for at-risk families (\$5,021).

4b (Code: 624100) (Expenses \$ 10,560 including grants of \$ 10,560) (Revenue \$ 0)

During 2017, a component fund of the MASSB Foundation provided the following services for Washington County Maryland's vulnerable or at-risk children, adults, and families: (1) operation of the Sunshine Center for Family Visitation, focused on providing family reunification and parental training for families separated for child protection purposes, (2) transportation to and from the Family Center, for job training and family counseling, (3) clothing and education-related supplies for at-risk children, (4) emergency housing and utility assistance; and (5) transportation assistance for medical or other assistance for those in need.

During 2017, a component fund of the MASSB Foundation (called the Queen Anne's County Family Assistance Fund) mainly provided services of the following kind for at-risk children and families in Queen Anne's County Maryland: enabling at-risk youths to attend summer camps (\$2,038), providing school supplies for at-risk children, and assisting vulnerable elderly through bedding, clothing, and other necessary supplies.
