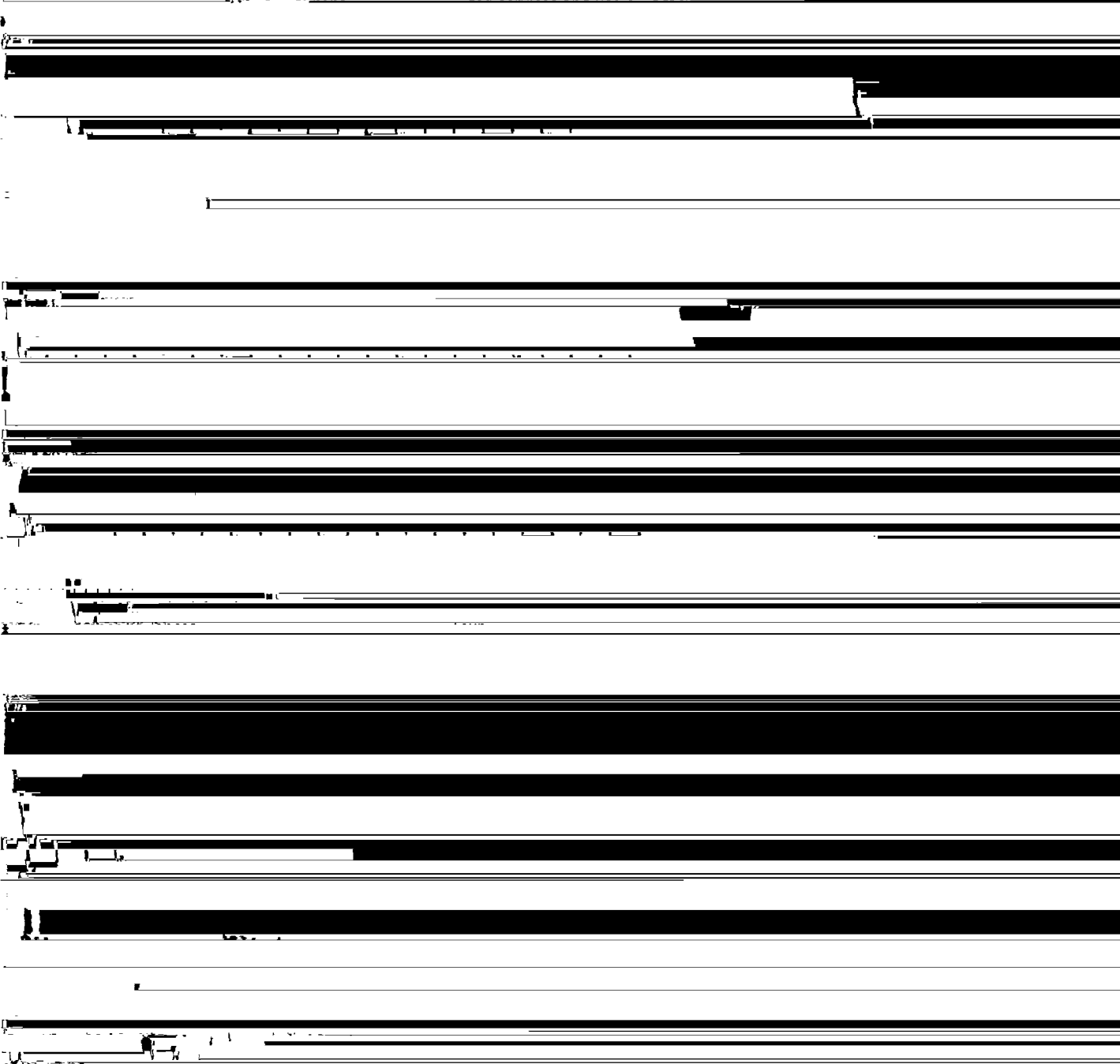

Over time, as the school has grown, children from the surrounding town have also been able to take advantage of the program.

ADios Ministries is currently investing in more than twenty students helping themselves attend university, and have a waiting list of other students waiting to join.

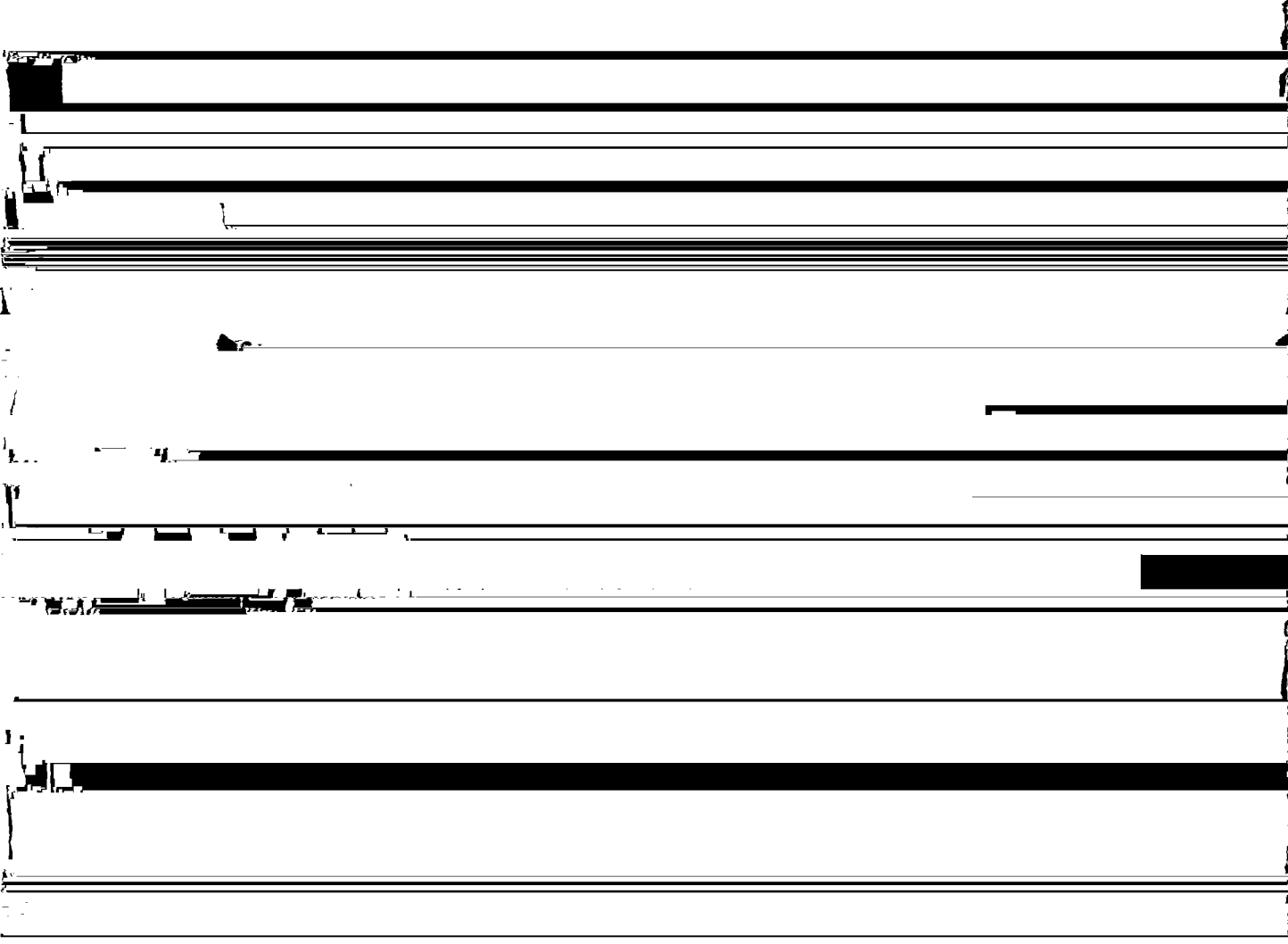
