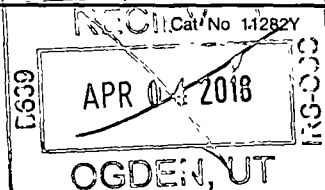

Each year for the next two years, we will add another class, until, in 2019, the school will offer form I through form IV and serve approximately 240 students. Construction continues throughout the year.
