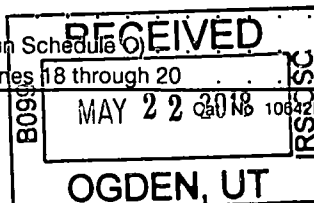

Pediatrics. Services provided at the clinic include rehabilitation for orthopedic, neurological, and developmental diagnoses. Home care is  
also provided one to two days per week in St. Elizabeth Parish. In 2017, the FOR U staff completed a total of 1,495 patient visits at the  
St. Vincent Strambi Health Center and 44 home visits throughout St. Elizabeth Parish.**

**STROKE CAMPS/ PEDIATRIC CAMP**

**In 2017, FOR U ran three stroke camps in March, May, and December. The September camp had to be canceled secondary to threat  
of a hurricane in the area. We continued using our new model which consisted of seven full days of intensive neurological rehabilitation  
as patients work to improve their gait, balance and arm/hand function. This change allowed implementation of home visits and  
community outings with patients which helped to increase their function in the community. Pre/post testing was done in the first and last  
days of the camp to measure functional changes in these areas. Eighty-five US/Jamaican volunteer physical therapists and physical  
therapy students from six different universities participated in the camps. A total of twenty-three patients were served, all of which  
made dramatic gains in their functional mobility. This program serves to further FOR U's exempt purposes by supporting charitable  
medical services to under-served populations and providing opportunities for volunteers to be involved with improving the quality of life  
for those living in under-served areas. Our objective of improving the quality of life of the people we serve was met by improving their  
functional mobility and helping them to become more independent with their activities of daily living. Our long term goal is to reduce the

incidence of stroke in Jamaica through raising awareness and health education to the public. In the future, we also aim to provide more comprehensive rehabilitation services including speech and occupational therapy as well a nutrition education and counseling.

FOR U hosted its first annual PEDIATRIC CAMP in May, led by Dr. Judy Prehn a pediatric specialist from William Carey University. The multidisciplinary team of PT, OT and speech therapists worked together to educate caregivers, make adaptive equipment, and create a plan of care for the ten children who participated. A parent's support group was also started that continues to meet at the clinic.

**SUMMER READING CAMP**

In July 2017 FOR U partnered with its sister organization, FOR U Jamaica to help support the ninth annual summer reading camp in Ridge, St. Elizabeth. The reading camp was held at the FOR U community center four days a week for two weeks from 8am-1pm. The camp was run by local teachers and high school students living in the community. The camp was overseen by an early childhood education instructor, who also developed the curriculum. Children were divided into 5 classrooms based on their reading level and each class had one to two teachers and one teacher's aide. To enrich their learning, the children participated in a craft activity each day. Lunch and snacks were provided by FOR U for all participants. Local volunteers were provided lunch and paid a small stipend for their assistance. Forty-seven children participated in this year's camp with an 81% improvement rate in their reading scores. This program helps to empower these children to become more productive community members and continues to further our goal of eliminating illiteracy in Ridge and the surrounding communities.
