

OPEN TO THE PUBLIC DAILY, THESE LOCATIONS ACCEPT DONATIONS OF UNWANTED MATERIALS, PROCESS THEM AND MAKE THEM AVAILABLE BACK TO THE COMMUNITY AT LOW COST. THIS PROGRAM ALSO OFFERS SERVICES TO DONORS AND CUSTOMERS INCLUDING FREE PICK-UPS OF DONATIONS, LOW-COST DELIVERY OF PURCHASES AND COMPUTER REPAIR. SHOPPERS MADE 104,000 VISITS TO THE TWO REUSE CENTERS IN 2017. AN ESTIMATED 420 TONS OF MATERIALS WERE DIVERTED FROM POTENTIALLY ENDING UP IN LANDFILLS THIS YEAR.
