Mentor North Carolina - In order to provide students with further high quality mentoring opportunities, in 2017 Movement of Youth agreed to provide the leadership & infrastructure necessary to support the expansion of quality mentoring relationships across North Carolina, with plans to expand to South Carolina in future years. This program is designed to serve a unique role as a clearinghouse for training, resources, public awareness and advocacy, providing the critical link between MENTOR's national efforts and local organizations and programs that foster and support quality mentoring relationships.

College Tours Visiting campus is one of the most important steps a student can take in deciding if a particular college is right for them. However, traveling to these campuses can be extremely expensive. As such, Movement of Youth, in collaboration with other community organizations, host Step to the Future College Tours annually where students visit colleges and universities across the country to get to know the students and faculty who bring these institutions to life. The 2017 Step to the Future College Tour featured tours of the following schools: Clark Atlanta University, Spelman College, Morehouse College, Stillman College, Tuskegee University, Troy University, Florida A&M University, and Florida State University.

International Program - Delegations & Volunteer Opportunities Movement of Youth partners with community organizations to send high school & college students of color to engage in international work & volunteerism abroad during the summer. These international experiences are designed to empower these students to be more effective, respectful of other cultures political and economic systems, and willing to take a stand for the world's welfare. In 2017 Movement of Youth was able to send 2 students to St. Vincent & the Grenadines to help to facilitate the ADARE Soccer camp while learning about the local culture and customs of the islands. Movement of Youth also sent 1 student on a Nicaragua Delegation led by WTP (Witness for Peace) where they learn about the country's history, politics, economics and how that relates to US foreign policy. Finally Movement of Youth sponsored 5 delegates on a WFP Cuban delegation which explored the race, politics and culture of Cuba through dynamic participatory people-to-people educational experiences & discussion.
