The Apparent Project has developed a program to train Haitians in bead making, jewelry making, sewing and other artistic trades. Seventeen to twenty assistant managers and artisans completed basic training in typing, Rosetta Stone English, Excel and Word. These skills gave them the ability to provide reports for management purposes. Shipped over 125,000 items for a 2017. This resulted in approximately 250 Haiti artisans being employed throughout the year.

Employees received basic training in typing, English, Excel and Word. These skills enhance their employability in Haiti, giving them lifetime opportunities that they haven't been able to acquire before.

4c (Code) (Expenses \$ 45,588. including grants of \$) (Revenue \$ 2,381.)

Over 25 "at risk" infants and toddlers were cared for Monday through Friday throughout the year, enabling the parents to work. Added a 5 year old kindergarten class to the Early Education program. There were 10 children enrolled. The 3 and 4 year old class had 14 children enrolled. After school childcare is provided to these children. Children are taught French and Creole, as well as being exposed to English through music and song.
