Partners in Health - Neno District, Malawi The Neno Chronic Care Clinics serves the rural Neno District in the southern region of Malawi. Receives referrals from five neighboring facilities and is a primary outpatient facility for 20,000 people in the district. Provides specialty services and referral support to the entire district of more than 165,000 people. Building the Chronic Care Center which will be comprised of two stand-alone buildings to house both the acute and chronic care service lines. Expecting over 200,000 visits per year, treatment for chronic illnesses such as HIV, tuberculosis, diabetes, integrated women's health services: prenatal care, cervical cancer screenings, family planning, pediatric care, acute visits for sick patients. CFC is providing professional project management expertise while utilizing local labor and materials to positively impact the local economy in addition to providing much needed infrastructure. Facility not complete in 2017. Integrate Health (formerly Hope Through Health) - Togo, West Africa Increase access to high quality health care in four clinics in the Kara region of Togo through extensive repairs and renovations to existing structures and the addition of a maternity ward at one location. Renovations include waiting rooms, hospitalization room, labor and delivery rooms, newborn care, midwife and birth attendant rooms. Utilization rate goals are at least 4 prenatal consultations, increase facility based deliveries from 33% to 85% with an emphasis on rigorous monitoring and evaluation to ensure high quality care. CFC is providing professional project management expertise while utilizing local labor and materials to positively impact the local economy in addition to providing much needed infrastructure. 30,000 people served Ndlovu Care Group- Limpopo, South Africa This facility serves over 7,600 HIV+ individuals in need of antiretroviral treatment and provides the Ndlovu Care Group with an HIV/AIDS vaccine and tuberculosis vaccine research facility. The areas served by this facility are considered "Presidential Poverty Nodes of Rural South Africa". They see high unemployment rates, low education rates and prenatal HIV rates between 19 and 27 percent. The Ndlovu Research Center (Part II) is a two-story solar-powered facility, which features a patient waiting area and care clinic with a one floor research facility and laboratory. This facility opened in the Fall of 2017. 7,600 people served Matibabu Foundation & Tiba Foundation - Ukwala, Kenya The expansion of the hospital will dramatically increase the number of patients that can be served. The long-term impact of the facility will be to reduce morbidity and mortality from the prevailing disease conditions in the area. Before renovations, the Matibabu Foundation Hospital handled more than 24,000 outpatient cases annually and more than 2,000 inpatient cases annually. With the renovations, it is anticipated that the caseload will more than double with the addition of 52 beds among the 4 new wards. Expansion on the Matibabu Foundation Hospital including the addition of 52 beds, as well as more adequate facilities such as medical rooms, surgical rooms, an isolation ward, pediatric ward, maternity ward, labor ward, and a postnatal room. The hospital will expand its work focused on providing inpatient services to both men and women for medical and surgical conditions. Facility not complete in 2017. Women's Protection Center Nepal - Hetauda, Nepal For 14 years, Women's Protection Center Nepal (WPC) and Hetauda House have been fighting to eradicate human trafficking and the sexual exploitation of women and children. Major programs include advocacy, healthcare, educational & preventative workshops in surrounding Nepali towns and villages, safe housing, and HIV/AIDS awareness & training. CFC and WPC rebuilt the Hetauda House, a safe house in the Makwanpur District of Nepal that was damaged by the earthquake. This new facility will provide a secure home for women and their children where case management, advocacy-based counseling, tutoring and educational development, and vocational skills training programs are available. With an expansion of the vocational training program, women will have the opportunity to move beyond the caste they were born into, and take their place in the world as educated, capable, confident, and employable. This program will break the cycle of poverty. 900 people served Flying Kites - Ngabini, Kenya In the foothills of Kenya's Aberdare Mountains, the Flying Kites Leadership Academy (FKLA) serves as a model school in a region where access to a basic education is not guaranteed. Here, critically-poor students receive a competitive education, characterized by small classrooms, progressive course material, integrative care, and inspired teachers. CFC built a student dormitory and designed a classroom block now under construction for Flying Kites School. 500 people served Bottomup - Cape Flats, South Africa The Parkwood Tech Centre is a project to expand on a computer laboratory at the Parkwood Primary School in the Cape Flats. The new Parkwood Tech Centre will serve the 500 students that attend the Parkwood Primary School. The expanded computer laboratory will provide space for new technology and education initiatives at Parkwood Primary School, as well as a space for Parkwood residents to acquire technology-related skills. Parkwood Technology Centre will benefit the students and educators at the school and in the larger Parkwood community, an area known for high rates of gang violence, drug use, and unemployment. 12,000 people served
