We also supply processing equipment, we support schools with locally produced food and educational material, and we provide agronomy training.**

**FRUIT TREES: working in cooperation with the Rural Agricultural Development Agency and other partner organizations in Jamaica, and Three Angels Childrens Relief nursery and others in Haiti, we distributed approximately 17,781 fruit trees. Fruit tree planting is the core of our operations. Our other programs exist to support this program.**

**EQUIPMENT: we supplied equipment to two community groups in Jamaica and one in Haiti. The equipment allows fresh fruit to be shredded or sliced, dried and ground into flour. The flour is a nutritious and easily stored ingredient for baking breads, other tasty foods, and a hot cereal porridge to provide a nutritious breakfast to young schoolchildren.**

**FOOD: we purchased and distributed over 9,600 pounds of breadfruit flour and over 2,100 pounds of porridge mix produced locally in Jamaica and Haiti, and in turn donated it to schools and orphanages. We estimate we have supplied over 120,000 meals to over 50 institutions for children.**
