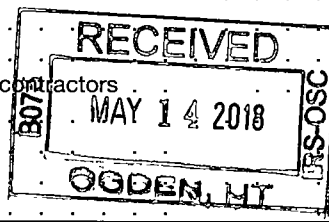

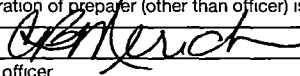

We did not have students enrolled during the 2017/2018 academic year. We will attempt to enroll students for the 2018/2019 academic year. Additionally, a grant was received from the City of Doral Community Based Organizations to provide a Parent-Training workshop for the residents of the city of Doral. We will providing this workshop by June 2018.
