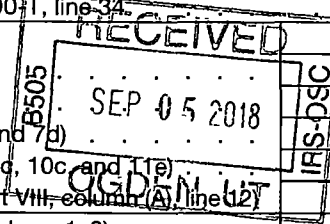

All questions and concerns are addressed at the board meeting, after which the 990 and any corrections are approved before transmission to the IRS.
