In the local Nebraska area of Omaha and Lincoln, Josh the Otter is included as part of the preschool, kindergarten and elementary schools. There are approximately 250,000 children who participate in Josh the Otter through Rotary club efforts. A new partnership between a Rotary club in Florida and the Paterson Foundation led to the distribution of 2,500 Josh the Otter books to incoming kindergarten students as part of kindergarten readiness days program. Over 250,000 Josh the Otter books have been distributed over the last (almost) 10 years, averaging 20,000 per year.
