

**PROGRAM NOTES**

**PRIDE FESTIVAL:** We held our largest festival yet, attracting approximately 15,000 people. We also had a record number of exhibitors

representing community services, health care, activist organizations, employers and local businesses. For the first time, we introduced

medical services at the festival, in the form of flu shots for the uninsured. Almost 100 people were vaccinated.

**COMMUNITY SUPPORT:** In November, we signed a lease for an LGBTQ Center in downtown Asheville - the only one in the area. We launched

a partnership with YouthOUTRight and Tranzmission and began refurbishing the facility for opening in 2018. This is a significant expansion

in scope for Blue Ridge Pride.

**COMMUNITY-BUILDING:** We launched Welcoming Communities of Faith. This is a precursor to a broader Welcoming Communities launch

planned for 2018 - to include Healthcare, Businesses, and Schools. We also began to invest in a significant innovation to be launched in 2018,

a Virtual LGBTQ Center. We believe that LGBTQ Centers in rural communities need a stronger virtual platform in order to serve isolated

members of the community. The center will connect people all over WNC to services, groups, events, training and other resources. It will

also support other non-profits and community service providers in their outreach efforts.
