The three program areas that received the bulk of Kupona Foundation funding and technical support in 2017 are (1) CCBRT's program for the treatment of women with obstetric fistula, including surgical treatment and recovery, the identification and transport of patients from more rural areas of the country, and their socioeconomic rehabilitation through skills training and business lessons, (2) CCBRT's efforts to scale high quality, low cost services for people living with blindness or visual impairment in Tanzania and to sustain these services for future generations, (3) CCBRT's maternal and newborn healthcare program, including both the training of nurses, midwives and doctors in maternal and neonatal health at 23 regional health facilities and preparations to open a new specialized maternal and newborn hospital in Dar es Salaam.
