Media & Communications - CLI continued its strong presence in national and specialized media in 2017. CLI publications were covered and/or CLI data and spokespeople were quoted or cited by The Atlantic, Nature, NPR, Science Magazine, The Washington Post, EWTN News Nightly, and many more. Opinion pieces written by CLI staff and associates appeared in Fox News Opinion, USA Today, The Boston Globe, The Cap Times (Wisconsin), TribTalk (Texas), The Washington Times, Washington Examiner, Western Journal, The Daily Caller, Townhall, The Daily Signal, and National Review Online. Overall, CLI edited and placed 51 op eds by associate scholars in national media outlets. In addition to its other program emphases, CLI supports individual ad-hoc writing and research projects on various topics in bioethics and sanctity of human life issues. These projects include policy papers, fact sheets, and commentaries for publication on CLI's web site or in the general media (print or electronic), blogs, and other formats. Writers are drawn from the CLI's list of more than 50 expert advisors. CLI also maintained active lists of interested members of the public, including donors, policy allies, and interested citizens. CLI communicates with each of these constituencies through its participation in a quarterly newsletter co-published with SBA List, print copies of its major reports, commentaries, fact sheets, social media, and email alerts announcing the release of new material. Most lists currently number in the hundreds of addresses and nearly all of these are domestic U.S. contacts. Subscriptions are free.

Legal Defense Fund - SBA Education Fund continued to support the Free Speech project launched in 2010. This project promotes freedom of speech on pro-life issues. Beginning in 2011, SBA Education Fund made grants to charitable organizations that fund legal action against state laws that unconstitutionally restrict the freedom of speech of pro-life groups and other organization in the public square.

Data Analytics - CLI created its first Data Analytics Department in 2017 to produce independent analysis of issues in public health and maternal-fetal medicine. CLI published its first article, on defects in the U.S. maternal health system, in a peer-reviewed journal. Of the 12 new associate scholars added to the CLI research and policy network in 2017, two have advanced (Ph.D.-level) degrees in public health metrics.

Adult stem cells continue to provide the gold standard for patient treatments, and the only validated health benefits, compared to the lack of therapeutic benefit achieved by use of embryo-destroying approaches and use of fetal tissue. CLI efforts include written publications and fact sheets, public education, media interviews, and our educational website, stemcellresearchfacts.org . In 2017, this website premiered our three widely-disseminated videos showing the personal success of adult stem cells through the eyes of patients and their doctors. The videos featured patients treated for leukemia, lupus, and stroke.

Pregnancy Center/Abortion Data Collection - CLI launched a comprehensive national project to promote improvements in the nation's public system for reporting the incidence of abortion and pertinent characteristics. To accomplish this goal, CLI worked sequentially through the newest reports issued by each of the 47 states that release annual reports and published summaries of key trends as well as recommendations for further improvements in data collection and publishing. We continue to advocate for improvements in federal reporting by the U.S. Centers for Disease Control. CLI maintained its contacts with U.S. pregnancy centers, advising on best practices, collecting data, and laying the groundwork for a 2018 project to survey total pregnancy center accomplishments in the U.S. CLI exposed unethical fetal tissue research and advocated for ethical research alternatives.
