Service to the Georgia Muslim community by delivering free educational presentations, including Know Your Rights seminars, Islamic Last Will workshops, Self-Defense seminars, and college lectures.

We held 33 Know Your Rights Seminars, 14, Last Will workshops, 3 Self Defense seminars and 7 college lectures. Combined these reached over 1600 people.

Protect Georgia Muslims by investigating anti-Muslim bigotry, building coalitions with other civil rights groups, and countering Islamophobia in both the court of law and public opinion.

We had over 500 calls to our office from people seeking assistance/advice. We managed 68 civil rights cases for issues relating to harassment, physical violence, workplace discrimination, public accommodation, government agency discrimination, etc.

Advocate for Georgia Muslims by interviewing all of Atlanta's top mayoral candidates, lobbying on Capitol Hill, delivering Islam 101 seminars, and interacting with local and national media.

We met with 10 Atlanta Mayoral candidates to discuss issues of importance to the Muslim community, we conducted 30 media interviews and help 20 public events including anti extremism, 3 rallies and 4 press conferences. We also conducted 23 Islam 101 presentations.
