 Shelter facility—This year our largest project was funding all architectural, construction and equipment costs for a new Medical Isolation & Wellness Building. This facility allows the Aiken County Animal Shelter (ACAS) to house animals with short-term treatable but contagious illnesses until they are cured and ready for adoption. FOTAS also arranged for the donation of a digital x-ray machine and paid for state license fees, set up and necessary training for shelter staff and purchased a new anesthesia machine for on-site surgeries

4b (Code:) (Expenses \$ 66,462 including grants of \$ 26,580) (Revenue \$ 80)
 Shelter operating needs—FOTAS supplemented the county's shelter budget by funding numerous items for hundreds of animals. These include medical treatment for 196 heartworm positive dogs which would otherwise prevent their adoption and flea treatments for hundreds of shelter cats and dogs. FOTAS provided collars, leashes, and toys for shelter animals and funded the enormously successful Dogs Playing for Life Group. This 5-day a week program helps socialize, exercise and enrich the lives of shelter dogs which in turn increases the live release rate. In honor of our military, FOTAS paid the fees for 50 veterans and active duty personnel who adopted cats and dogs from ACAS in 2017

4c (Code:) (Expenses \$ 55,240, including grants of \$ 20,925) (Revenue \$ 28,705)
 Transfers and foster—Due to overcrowding at the county animal shelter, FOTAS worked aggressively to transport as many adoptable animals as possible to no-kill shelters. The transfer program includes an extensive network of volunteers who foster pets until they are old enough or healthy enough for transport. In 2017, FOTAS organized 84 transfers totaling 1,350 adoptable dogs and cats to no-kill out-of-state partner shelters and South Carolina-based rescue groups. This program is by far the most successful of our initiatives to increase our live release rate from a dismal 9 percent in 2009 to an incredible 83 percent in 2017. We are working hard to increase the save rate to our goal of over 90 percent so that ACAS may be classified as a no-kill shelter
