The Creating a Family website, creatingafamily.org is the focal point of the organization. We are almost entirely a web based entity. The website is our primary means of providing support and unbiased information to those dealing with adoption, foster care or infertility. The website received over 8 million hits monthly. The site averaged 145,000 visits per month and in excess of 96,000 unique visitors monthly. There is no charge for the vast majority of the information on the website. There is a charge for the On-line Education courses (see below)

In 2017, Creating a Family launched the rollout of their On-Line Education Courses. These are one hour audio courses that can be accessed on your phone or computer. There are over 100 courses on a variety of topics in the fields of adoption, foster care and infertility. Participants can obtain Certificates of Completion by listening to a one hour video and successfully completing a quiz afterwards. In 2017, over 8,800 courses were acquired.
